General Condition

Roscoe Roll-off, Inc. (The Company) and the customer-named herein (The customer) agrees that the Company shall provide a non- hazardous material collection removal.

Non-hazardous material only

Customer shall use the equipment only for non-hazardous material and agrees that if places waste which is liquid, radioactive, reactive, toxic ignitable, corrosive, pathological, acidic, or material, which is otherwise listed as a hazardous or toxic substance (as defined by local, state, provincial or Federal laws or regulations in the equipment), (a) it shall indemnify the Company for any and all damages, losses or claims which may be incurred by the Company; and (b) that title to any such material shall not pass to Company but shall remain with the Customer.

Customer's responsibility

Customer shall provide a suitable site for Equipment and hereby grants the Company the right of access to the Equipment at all reasonable times in order to provide the service or inspect the Equipment. The Company shall not be liable for Customer waives and any claims against the Company for any damage to pavement or driving surface resulting from the Equipment or Company trucks servicing the Equipment. Customer will assume all risks by requesting the truck driver to drop off a container on a property including all possible damage(s) to the property. The Company suggests getting a permit from the city and drop the bin on the street; thus there will be no assumed risk towards any property damage to the driveway, gates or walls. Customer shall indemnify the Company for any and all losses, damages, or claims (including attorney's fees) relating to loss of, or damage to the Equipment, or the property of or injury to or death of any person(s), resulting from or arising in any manner out of Customer's breach of this agreement or the use, operation or possession of the Equipment by the Customer.

*All containers have weight and height limitation. Dump materials can't pass the bin's height. Each extra ton will be charged \$100.00 per ton. Rain will add extra weight to your trash; we suggest covering your bin with plastic roll. Any unsuccessful service or cancellation charge is \$150.00.

*Solid Inert like dirt, concrete, brick, tile and asphalt (without any trash) need 10 yard container that has no weight limitation. Solid inert mixed with trash will have extra charge up to \$1000. Customer is responsible for daily inspection of the bin to prevent unauthorized dumping. Any container containing dirt should be completely covered when raining, otherwise; \$250 extra charges. Customer is responsible for calling on time for any container pick up and do follow up calls till the container gets picked up. Customer is responsible for the bin until, the bin gets picked up by the company. Customer by saying; "I called for pick up" is not released from extra charges. Customer needs to do follow up calls, if necessary.

Customer is responsible for permit, losses and/or damages of the bin. Please don't pass the bin's height limit (\$50 charge).

We don't take hazardous materials like; TV, computer monitor, printer, DVD, oil, tire, fluorescent light, paint & battery.

Call one day in advance for delivery, pick up or exchange of a container. After 7 days, there will be \$5.00 per day charge.
